

# **Achieve Well Health and Wellbeing Awards**

#### Introduction

The Achieve Well Health and Wellbeing Awards programme aims to recognise and celebrate education settings in Nottingham that are implementing a whole school approach to improving health and wellbeing.

We offer three levels of Award:



This school actively supports health and wellbeing through self-assessment, development, and review.



This school actively champions health and wellbeing through verified provision and sharing good practice.



This school prioritises health and wellbeing, making measurable improvements to provision and a positive impact.

The Achieve Well Team and Awards Programme are funded by Public Health to improve the health and wellbeing of children and adults in Nottingham. The Awards support schools to work towards our vision for the Nottingham Healthy Child.

## **Foundation Awards**

Our foundation awards cover the basics of a whole school approach to health and wellbeing. The process from sign-up to completion is outlined in the steps below.

#### Choose your award:

There are two foundation level awards, Essentials, and Champion. All schools must complete a foundation level award before progressing to our <u>Impact Awards</u>. The Essentials and Champion Awards have the same benchmarks and criteria but are assessed differently.

#### **Essentials**

Schools following the Essentials Award route demonstrate that they 'actively support health and wellbeing through self-assessment, development, and review'. The Essentials award is a self-assessment process, with schools auditing their practice, action planning, and implementing improvements. There is no external verification for the Essentials award. Once a school has marked all criteria as 'green' they receive a certificate and logo to acknowledge their achievement. Essentials award status remains for a period of 3 years when the school must re-assess to maintain their award.

# Champion

Schools following the Champion Award route demonstrate that they 'actively champion health and wellbeing through verified provision and sharing good practice'. The Champion Award is verified by an Achieve Well Team assessor. Schools audit their practice, action plan, implement improvements and upload evidence for each criteria. Once all criteria are 'green' the school arranges a verification visit from an assessor. Champion status remains for a period of 3 years, after which a school must reassess. To maintain Champion status, schools must attend at least one <a href="Achieve Well network">Achieve Well network</a> meeting per annum, share good practice through a case study, presentation at a network, or by supporting another school, plus complete an annual audit on the Achieve Well Awards platform.

#### **Benchmarks and Criteria**

There are seven benchmarks for the foundation awards, each with 5 criteria:

A safe and supportive environment for children and adults	<ol> <li>Children and adults are signposted to relevant and needs-led health and wellbeing support as and when appropriate</li> <li>Bullying, harmful behaviours and discrimination are effectively addressed and actively challenged</li> <li>There is embedded pastoral support that all children can access and specialist support onsite</li> <li>There are strong links and relevant information sharing between pastoral and safeguarding colleagues</li> <li>Provision for support meets the needs of all children</li> </ol>

#### Sign up:

To sign-up for the Achieve Well Awards please complete the expression of interest form <a href="here">here</a>. You will be sent an SLA and data processing agreement to sign and return. By signing up to the awards you commit to our <a href="Nottingham Healthy Child vision">Nottingham Healthy Child vision</a>. Once the SLA and data processing agreement are signed you will receive your log-in details for the <a href="Achieve Well Award platform">Achieve Well Award platform</a>.

#### **Create an Award Team:**

Appoint an award lead who will co-ordinate activity towards achieving the award criteria. We recommend that a working group is set up to take forward the action plan. This working group will meet regularly to monitor progress and take forward actions. As these awards are based on a whole school approach, it is useful to have representatives from a range of stakeholders, for instance, governors/trustees, leaders, members of staff, pupils, and parents.

### **Audit your provision:**

Begin by auditing your current provision against the <u>criteria for each benchmark</u>. Each benchmark is shown on the wheel as a segment with 5 sections representing the criteria. By clicking on a section, you can view the required good practice which is needed to achieve the criteria. For some criteria there are optional examples of good practice which will further strengthen your provision.

For each criteria, tick the required good practice examples that you know are currently in place in your school. If you meet all required good practice in a section, it will show as green on the wheel, and amber if only some are met. If you do not tick any required good practice examples, the section remains blank. You can manually identify this as a target area by pressing the red Target button on the top bar.

You do not need to complete this in one sitting as your progress will be saved. It may be useful to discuss the benchmarks and criteria with your award team before completing the wheel. You can find hard copies of the <u>benchmarks and criteria here for this purpose</u>.

#### Create and implement an action plan:

Once you have completed your initial audit, create an <u>action plan</u> with your award team to address any red or amber criteria.

Develop specific, measurable, achievable, realistic, time-limited actions to improve your practice. As you achieve your actions, record on the award wheel.

If you would like to capture your progress over time, we recommend that you record a new assessment each time you update your wheel. You will find details of how to do that <a href="here">here</a>. ## Access support as required:

**Achieve Well Award networks** – you can find details of our <u>award networks on our website</u>. These networks provide an opportunity to learn from others, share good practice as well as receive input from the Achieve Well team.

**Training** - You can find out about on demand, virtual and face-to-face training opportunities <u>via our website.</u>

**Advisor support** (Champion only) – Schools following the Champion route can request support from their advisor.

## **Upload evidence (Champion Award only):**

If you are working towards the Champion Award you will need to upload one piece of evidence per criteria. Please see the Foundation Awards overview for evidence requirements.

Once you have uploaded all your evidence and each criteria is marked 'green', email your advisor to begin the assessment process. Your advisor will notify the assessor who will review your uploaded evidence to ensure each criteria is evidenced effectively.

Please ensure that any evidence uploaded is redacted and does not contain personal identifiers.

## Host accreditation visit (Champion Award only):

Once uploaded evidence has been verified, your assessor will arrange an accreditation visit. The assessor will be looking for evidence to show that each criteria has been met.

The verification visit will include:

- A presentation from the award lead plus questions from the assessor
- A presentation from pupils
- A tour of the school
- Stakeholder interviews

The assessor will notify you on the day of the visit if you have been successful. If you do not meet the standard for accreditation at this time, you will be advised of actions to be taken to achieve it.

#### Celebrate:

**Essentials Award** – Once you have met all criteria by marking them 'green', please <u>notify the team</u>. You will receive a logo and certificate to recognise your achievement. You may want to host an event to celebrate. If you are sharing your successes on social media please tag @AchieveWellTeam on X and use the hashtag #AchieveWellAwards. Your achievement will be displayed on the Achieve Well website and celebrated on our social media.

**Champion Award** – Once the assessment visit has been successfully completed, you will receive a logo and certificate to recognise your achievement. You may want to host an event to celebrate. If you are sharing your successes on social media please tag @AchieveWellTeam on X and use the hashtag #AchieveWellAwards. Your achievement will be displayed on the Achieve Well website and celebrated on our social media.

## Maintain accreditation (Champion Award only):

To maintain Champion status, schools must attend at least one Achieve Well network meeting per annum, share good practice through a case study, presentation at a network, or by supporting another school, plus complete an annual audit on the Achieve Well Awards platform.

#### Review:

Both foundation awards are subject to a 3 yearly re-assessment process.

Essentials Award - At the point of review, schools return to their wheel and carry out another audit, then create and implement an action plan as required. Once all criteria are green, the school will be re-awarded with the Essentials award.

Champion Award - At the point of review, schools return to their wheel and carry out another audit, then create and implement an action plan as required. Once all criteria are green, another

verification visit will be planned. If a school meets all the criteria, they will maintain their Award subject to requirements outlined above.
Impact Awards:
Once schools have completed a foundation award, they can move on to the <a href="Impact Awards">Impact Awards</a> . As the name suggests, Impact Awards focus on making measurable change in a specific theme. There are Impact Awards in the following areas: Healthy Eating; Physical Activity; Gambling and Gaming; Internet Safety; Drugs and Alcohol; Smoking and Vaping; Aspirations and Goals; Sexual Health (secondary); Healthy Relationships; Health Protection; Emotional Health and Wellbeing; and, Financial Wellbeing.
